F. 9:30-10:00 Dr. Mark McLaughlin, Superintendent

- I. Post fire update, vision for SPED and hopes for SEDAC
 - a. November was a difficult month with Borderline and the fires and with making the decision to close schools for 7 days.
 - b. Cabinet spent most of day working on figuring out how a plan to move forward for students, staff and community as a whole.
 - c. All the crews came in and cleaned all of our sites. Insurance sent in cleaning crews for the hardest hit of all the sites.
 - d. Home Depot sent out a cleaning crew to Sycamore Canyon
 - e. The news agencies did a great job of covering everything.
 - f. Sports Academy took in many of our kids (complementary) during this time.
 - g. The Community came together and many people stepped up to help.
 - h. It was important to make sure that everything came together for social emotional needs of our students and staff. Lisa and staff worked with Principals and sites on what the next steps would be when the kids and staff came back.
 - i. Parents thanked the Superintendent, Cabinet and staff for everything they did.
 - j. Parents appreciated the survey and results.
 - k. Parent thankful for the severe precaution the District took for students with lung and breathing problems.
 - l. Parent appreciated the thought that went into carrying for teachers, and staff-so that they were ready for the students.
 - m. Parents appreciated that Lisa's group sent out talking points for how we talk to the kids at the different grade levels.
 - n. Parent asked to please pass on to staff thank you and how extraordinary everyone handled these tragedies.
- II. Superintendents vision of SEDAC and SPED
 - a. SEDAC-glad that it is back, up, running, and has a voice.

- b. Mark is glad that there is a Committee to provide feedback to the District
- c. The District's priority is to the kids.
- d. Mark's vision is that we move forward, be engaged, adjust protocols not working and put protocols in place that help kids and families.
- e. You have access to Lisa and her department; let your voice be heard.
- f. Through course of next few meetings, we will share our Data and Dashboard and how we train our teachers in the classrooms to work on some of our issues.

- III. Why the high turnover of Para pros? *There is less turnover with the additional hours and benefits that we have implemented this year.*
 - IV. In the vision of the District and SPED, is there a plan for a full inclusion magnet? *There are Pros and cons to this. Anything is possible; but our current vision is that we want kids to feel that they can go to any of our schools and be successful. If we limit them to one school, then it might feel more like a program.*
 - V. Comment-*a lot of administrators, teachers etc. come into his restaurant. A lot of positive energy and change from parents talking about Sped.*
 - VI. Any thought about applying for grant money for some changes? *Yes. We don't have a grant writer for the district, so it makes it a little challenging. When the grant runs out and it's a great program, we have to figure out if and how we are going to incorporate the program.*
- G. Board of Education Meeting Updates
- I. Three new members. Cindy Goldberg, Jenny Fitzgerald and Bill Gorback.
 - II. Betsy Connolly-President, Cindy Goldberg-Vice President, Bill Gorback-Board Clerk, Sandee Everett and Jenny Fitzgerald-Member(s).
 - III. Election system for school Board will be changing from at large representation to area elections. We received a demand letter, so now we are looking into dividing into five districts. Each area would have a Board Member to represent that specific area (instead of at large). There will be several public hearings to discuss this and the zoning, before this would be implemented. You can see info that was presented at the last Board meeting, on DO web site. The turnovers would not happen until the natural cycle of election.
- H. Standing Committee Reports
- I. The IEP Process was brainstormed. Three action items (1) how do we want to define best process for IEP's; (2) they are working on developing a tool kit for parents; clearly defining IEP process, assessments, interventions etc. (3)How are we incorporating social emotional goals into the IEP process. They will put everything on Google Docs when done.

- I. Aspen had ability's awareness last week. Approximately 40 parent volunteers came in. They were mostly from Gen Ed population. There theme was "empathy is my superpower".

something different. School wide was a big assembly “making kindness normal.”

- IV. Be Me-parent met with Shane Craven with some concerns. He was very impressed that Shane implemented changes per their concerns right away (ex. volunteering into the classrooms). They are considering trying to get a PTA started at the Preschool.

 - II. Mental Health-focus on wellness and mental health
 - a. Last year - 1st year kept data on how we are providing services to our students and how many are we seeing and there are over 1300 kids.
 - b. This is a collaborative effort-5 elementary counselors; 9 middle school counselors; 16 high school counselors; 1 title one social worker; 11 secondary wellness counselors (MSW and MFT interns); 2 Breakthrough counselors; 11 intensive school based therapists (4 licenses and rest interns); 2 licensed clinicians; 19 school psychologists;
 - c. Who can make referrals,
 - i. Students, parents or students can make referral
 - ii. SST

 - iv. Section 504 or SPED
 - v. School counselors or Psychs
 - d. Suicide prevention –we are moving full force on this and doing Risk assessments. Every school site has someone trained to do this. Heather Chamberlain will go help and schools that need additional help.
 - e. Suicide prevention task force-staff continued trainings and going to sites to do training
 - f. Breakthrough-11 parent workshops with 700 parents participating.
 - g. Last year we completed 181 risk assessments, this year we are already over 100.
 - h. 271 students receiving social emotional services through IEP. Higher level is ERSES and needs an assessment. We are the only district that has our own ERSES staff.
 - i. Conejo Closet-extra items are needed for donation for families that are homeless. If you have items to donate, email Lisa.
 - j. We are working on providing a lot of PD on suicide prevention.
