III. Information/Discussion Items

- **A.** Presentation: No Harm Grading Policy Review, Dr. Deborah Martinez, Coordinator of English Learner Services
 - Grades TK-2 students will not receive a pass/no pass nor a met/not met, but rather a standards-based progress update based on Distance Learning Essential Standards and abbreviated assessments that could be given live online or via online learning systems in use by teachers (SeeSaw or Google Classroom).
 - Grades 3-8 students will earn a final "Pass/No Pass" mark at the end of this trimester based on their Trimester 2 grade, and any completed work or assessments beginning April 27, 2020. A "Pass" is 60% or above, while a "No Pass" is less than 60%.
 - Grades 6-8 a student's assignments and grade in "Q" will still utilize a letter grade calculation during the grading term. However, at the end of the marking term, the final letter grade and percent will translate into "Pass" or "No Pass."
 - High School (9-12) students will earn letter grades at the end of this semester which will be reflected on their transcript and be based on Quarter 3 grades reported as of March 27, 2020, and any completed work or assessments beginning April 27, 2020. "Do No Harm" means that the students' final grade will not be lower than the grade earned for Quarter 3 or Term 2 Semester 1.
 - Students may increase their grades with completed work and/or assessments during this period of school closures. It is expected that students remain engaged to the highest degree possible and complete all assigned work and assessments as determined by their teacher(s).
 - Grades for Students with an Individualized Education Plan (IEP) or a Section 504 Plan: Students will earn and be assigned marks (letter grades, Pass/No Pass, or standards based) as described above by grade span, and shall reflect the student's performance inclusive of all accommodations and supports made available "to the extent feasible" during distance learning
- **B.** Presentation: High School Distance Learning Tutoring Program for Elementary Students, Mr. Brian Mercer, Director of High School and Assessment & Dr. Jayna Suter, Coordinator of Instructional Technology and Assessment

History and how it's grown and the future of this program.

Born from creating some support for ELs, but then it morphed into being about all students that had the most needs - elementary students

150 students that had tutoring experience and were interested in tutoring. Focused on the bilingual students. Training on: scheduling, safety, Zoom training. It Launched in May 4th (after a week n half)

Limit of one 30 minute session per week.

54 tutors currently.

Example of how to create an appointment

Expectations:

An adult with Student when on session with a student.

Appropriate clothing(school dress code)

Keeping area free of distraction while providing support

Listening, answering questions and being positive and asking questions

Would like to continue with this program even after going back to classroom schooling.

Q: Sometimes 30 minutes is not enough since it takes a while for them to understand what the student needs help with, is there a way to get what the student needs help with beforehand? A: There is a feature when scheduling the appointment for notes and you can add that information there. If availability, students can add another session.

Q: Planning to put some of this in place for High School Students, for example the ELs in secondary? A: Plans are in the works for that. This year the focus was the elem. students and next year for secondary.

Q: How can we make sure others parents know about this? A: Principals were notified and we can communicate with them again as to keep

Q: Will this continue over summer? A: We did not put an end date, but we will be meeting with the kids to see how many will be continuing or will be leaving. We do have alternates in case we have some that leave.
