Welcome to the CVUSD! We look forward to a productive partnership in education with you and your child. 2019/2020 Registration for students in Kindergarten through Grade 12 begins on, January 22, 2019, at your neighborhood school. To register for Transitional Kindergarten (TK), please complete a School Choice Application on our website www.conejousd.org (School Choice Application will be available on November 1, 2018). TK schools include Acacia, Aspen, Cypress, Glenwood, Madrona, Maple, Walnut, Weathersfield, Westlake, and Westlake Hills (subject to change based upon enrollment). Children born between September 2, 2014 and December 2, 2014 are eligible for TK. Children born between July 1, 2014 and September 1, 2014 are eligible for TK or Kindergarten.

Checklist for New Student Enrollment

What do I need to enroll my child? (All documents must be original unless otherwise specified.)

1. Online Pre-Enrollment

2. Verification of Parent/Guardian Identity:

Any **one** of the following items (with picture) is acceptable for verification of identity:

- Valid California driver's license (with current home address)
- California ID card
- Passport, Visa, or Consulate ID card

3. Conejo Valley USD Residents:

- Proof of Residency

(See District Residency Requirements Form)

Interdistrict Permit Students:

- Interdistrict Transfer Permit (approved by CVUSD)

4. Verification of Student Date of Birth:

One of the following items is acceptable for verification of date of birth:

- Original or Certified copy of Birth certificate (preferred, with the names of the parents)
- Passport

5. Verification of Immunizations: (via the doctor's immunization record, yellow card, health records from another school, or Report of Health Examination for School Entry form signed and stamped by health provider)

Students will not be enrolled until all California immunization requirements are met.

*A physician may use medical exemption documentation for a child who has had physician-confirmed chickenpox disease.

- Tdap

*Students entering or advancing to grades 7 through 12 need a pertussis (Tdap) vaccine prior to beginning the school year.

6. Health Examination for School Entry: TK Parents: Physical examination should occur no earlier than March of TK enrollment year. Students in Kindergarten or First Grade submit a certification form signed by the student's health care examiner, certifying that the student has completed a comprehensive health screening within 18 months prior to entry into first grade or within 90 days thereafter.

- Health Examination for School Entry Report (parent completes part I; physician completes part II)
- Oral Health Assessment (An Oral Health Assessment/dental exam is required by May 31 in either kindergarten or first grade, whichever is the student's first year in public school.)
