



# California School Employees Association Chapter 620-CVUSD SCHOLARSHIP



These scholarships are available to graduating high school seniors who are dependents of classified employees (CSEA chapter 620 members) of the Conejo Valley Unified School District. Applicants may qualify for scholarships based on academic merit, leadership qualities, community involvement, and other personal qualifications. The number of scholarships may vary depending upon the amount of scholarship funds available.

## **Eligibility Requirements**

- ◆ Applicant must be a graduating high school senior.
- ◆ Applicant must be a dependent of a CSEA chapter 620 member and employee of Conejo Valley Unified School District.
- ◆ Applicant must be planning to enter, as full-time student, an accredited college by the fall term following the granting of the scholarship (Accredited colleges include community colleges, offering trade and vocational programs, other accredited trade or vocational schools, as well as four-year institutions)
- ◆ Applicant must have a cumulative minimum grade point average of 2.5

## **Application Requirements**

- ◆ Completed scholarship application form
- ◆ Two letters of recommendation from a teacher, employer or community leader
- ◆ Transcripts (photocopy of official transcript is acceptable)
- ◆ Copy of letter of acceptance from college, university, community college, or vocational education institution applicant will attend, or statement explaining acceptance.

## **Scholarship Committee**

The Scholarship Committee shall consist of three to five CSEA members of the Conejo Valley Unified School District. A list of applicants with name, department, or employee relationship will be provided prior to review of applications to establish potential conflict of interest issues. Any Committee member who works with or personally knows an applicant will be expected to excuse him or herself from the Committee. Casual knowledge of an applicant is not sufficient to warrant the exclusion from the review and/or discussion of that application.

## **Miscellaneous**

The CSEA-CVUSD Scholarship Committee reserves the right to use the name and/or photograph of scholarship award recipients in promotional materials designed to increase awareness of the scholarship fund. The Scholarship Committee will not accept any applications where applicants do not meet minimum GPA requirements or where specific directions have not been followed, or where required documentation has not been included.

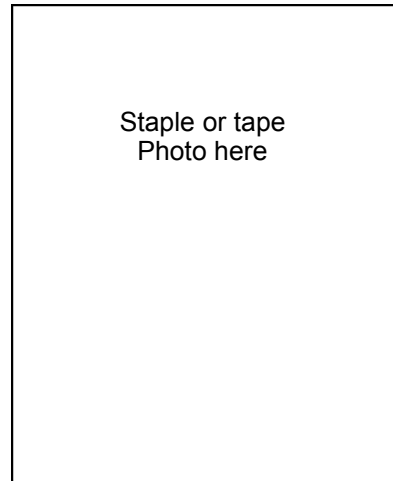
