### 1. OPEN SESSION

#### A. Call the Meeting to Order and Roll Call

Call to Order and Roll Call: President Goldberg called the meeting to order at 6:01 p.m.  
Board Members present: President Cindy Goldberg, Vice President Jenny Fitzgerald, Bill Gorback, Sandee Everett, Dr. Betsy Connolly, and Student Board Trustee Addie Craig.

***Vote to call for the question:* Motion failed, 4-1, with Mrs. Fitzgerald voting "yes," President Goldberg, Dr. Connolly, Mrs. Everett and Mr. Gorback voting "no," and Student Board Trustee Craig voting "no."**

Board discussion continued, to which District staff provided clarifications.

Dr. Connolly called for the question, which was seconded by Mrs. Fitzgerald. **Motion carried: 4-0, with President Goldberg, Mrs. Fitzgerald, Mr. Gorback and Dr. Connolly voting "yes." Mrs. Everett did not cast a vote. When President Goldberg requested her vote, Mrs. Everett attempted to continue her presentation/discussion on the item. Student Board Trustee Craig voted "yes."**

**Vote to approve the agenda item: Motion carried: 4-1, with President Goldberg, Mrs. Fitzgerald, Mr. Gorback and Dr. Connolly voting "yes." Mrs. Everett voted "no." Student Board Trustee Craig voted "yes."**


