1.	General Clarification	At the Job Walk today July 7, 2020, it was brought to the District's attention that the grading and grubbing was inadvertently included in the Landscape Bid Pack.
2.	Landscape Bid Package	Remove all reference to Grading and Grubbing from the Landscaping Scope of work as provided in the Bid Walk Agenda distributed today. Fine grading <b>ONLY</b> will be the responsibility of the Landscape Contractor under his/hers Bid Pack.
3.	Grading Scope of Work	ADD the following to the Asphalt Package. All over-ex work, grubbing, re-compaction and rough grading will be included under this Bid Pack. The installation of the drainage system @ the parking lot is part of the Asphalt Contractor Scope of Work as well.
4.	Grading Scope of Work	Export of unused soils and grubbing generated as part of the Asphalt Bid Pack is the responsibility of the Asphalt Contractor.
