October 11, 2005 <u>M I N U T E S</u>

CALL TO ORDER – CLOSED SESSION

The Board meeting of October 11, 2005, was called to order by President Timothy Stephens at 5:45 p.m. Dr. Stephens asked if there were any public speakers for the Closed Session agenda items; Mrs. Janet Powell, Newbury Park, spoke in regard to Closed Session item #2. The Board adjourned into Closed Session at 5:55 p.m., where the following items were discussed:

The Closed Session ended at 6:10 p.m. Dr. Stephens announced that the Board took no formal action during Closed Session.

CALL TO ORDER – OPEN SESSION

OPENING PROVISIONS

President Stephens called the meeting to order at 6:13 p.m., and led the Pledge of Allegiance. President Stephens welcomed guests and read the procedural announcements.

Dr. Stephens welcomed and introduced the Student Board Representatives.

Approval of Agenda

Mrs. Beaubien moved to <u>approve the addition of Action Item #A1, Resolution #05/06-08: Opposition to</u> <u>Resolution 76 – the California Live Within Our Means Act and to approve the agenda</u>, seconded by Mrs. Phelps. Motion carried 4-0.

Reports from Student Board Representatives

Morgan Lopker, Thousand Oaks High School, sat with the Board. Morgan, along with Kelly Feiweles, Westlake High School, Kyle Greenberg, Conejo Valley/Century High Schools, and Jill Zino, Newbury Park High School, provided the Board with reports from their schools regarding topics such as tutoring programs, rallies, athletics, College Night, Red Ribbon Week, Homecoming events, PSAT tests, fund raisers, school-to-career events, Relay for Life, Student Senate, Script sales, and band activities.

Reports from Support Organizations Leadership

Betsy Connolly, Chairperson, District Advisory Council, stated that the council at its first meeting of the year was especially please to hear about improvements in test scores among struggling students and summer construction improvements District-wide. Ms. Connolly thanked the District for handling information and communication to parents regarding the surrounding fires a couple of weeks ago.

Sue Wells, Conejo Council PTA President, thanked the District for the cluster breakfasts that were held a couple of weeks ago and mentioned: Reflections reception November 21 at Thousand Oaks High School Performing Arts Center; Parent Education Night regarding gangs, drugs and what's happening in our community on November 3, 7:00 p.m. at Los Cerritos Middle School; Red Ribbon Week activities; and the council's opposition to Proposition 76. Ms. Wells stated that this year she would invite a unit president from each of the schools to present information from their unit. She introduced Mary Maki from University Elementary School, who discussed the welcome back BBQ for University families, the unit's work in the school's garden in August, updating the earthquake kits at the school, and some of the disbursements of funds raised such as \$10,800 to the playground fund, \$2,000 to the library, \$1,500 to the technology department at the school. The goals of PTA at University this year are to maintain programs and services already in place, fix handball courts, and continue to upgrade the playground.

Comments from the Superintendent

Dr. Fraisse introduced Mike Berger, Principal, Conejo Valley Adult School, to discuss some of the programs available at the site. Mr. Berger welcomed Century High School's relocation to the Adult Ed site, welcomed the adult ESL participants; stated that 40 disabled adults were housed at the site during the fires; announced the professional development centers offering back and front medical office

training, computer applications and IT programs; parent-teacher talk programs; concert series for preschoolers; Pell Grant offerings; and WASC accreditation this year.

Dr. Fraisse complimented the fire department, District staff and community for their responses to the fires, and credited Dr. Stephens for the idea and Dr. Simpson for implementing the communication system which allowed the district to reach 74,000 phones in a matter of minutes to communicate the status of the schools during the fires.

Dr. Fraisse also reminded the community about the October 25 Study Session (open to the public), which will address long and medium term planning for facilities.

Comments from the Public

Stan McClain, President, California Schools Employees Association (CSEA) Chapter 620, presented the unit's initial proposal for a three-year contract.

Peggy Buckles, President, Tri-County Education Coalition, read a resolution opposing Proposition 76.

Suzanne Duckett, Thousand Oaks, complimented Sue Wells, Conejo Council PTA President, and Jo-Ann Yoos, Assistant Superintendent, Personnel. Ms. Duckett discussed her concern about the District's alternative P.E. program.

Cathy Carlson, Thousand Oaks, presented her interpretation of the District's API scores and discussed her concern about the District complying with the Williams Act. (Tom Ritch, Thousand Oaks, gave his three minute speaking time to Mrs. Carlson.)

Elaine McKearn, Thousand Oaks, spoke about media inaccuracies.

Mrs. Phelps moved to <u>support the CSBA/ACSA resolution opposing Proposition 76</u>, seconded by Mrs. Beaubien. Mike Dunn stated why he would not support this resolution. John Anderson, Newbury Park, stated that he felt that bringing this resolution to the Board as an add-on item was politically motivated. Three public written statement cards in favor of the Resolution to oppose Proposition 76 were received: Ingrid Van Eckert of Thousand Oaks, Penne Letson of Thousand Oaks, and Bruce Gardner of Thousand Oaks. Motion carried 3-0-1, with Mr. Dunn abstaining.
