2. OPEN SESSION

A. Call the Meeting to Order

Call to Order: President Gill called the meeting to order at 6:01 p.m.

President Gill asked for attendees to remain standing after the Pledge of Allegiance for a moment of silence to honor the passing of Westlake High School student Julius Poppinga.

Trustee Gorback made the motion to approve, seconded by Trustee Powell. President Gill announced that there was one (1) public comment request submitted, and that speaker received three (3) minutes to speak. There was no Board discussion on this agenda item. **Motion carried:** 5-0, with a preferential "yes" vote from Trustee Kahl.

B. Student Services – Adoption of Resolution #23/24-04 in Support of Unity DayTrustee Powell made the motion to approve, seconded by Trustee Goldberg. There was no Board discussion on this agenda item. **Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.**

C. Business Services - Approval of 2022-2023 Unaudited Actual Financial Report

Trustee Goldberg made the motion to approve, seconded by Trustee Powell. Dr. Hayek provided information on the 2022-2023 Unaudited Actual Financial Report, including a breakdown of the restricted and unrestricted revenues and expenses, fund balances, and other district funds. Dr. Hayek responded to questions from Board members regarding unrestricted

ending balances as compared to last year and a clarification on Child Development department oversight. **Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.**

Mr. Loo responded to a Board member's questions regarding the origination and purpose of this agreement, whether coaches and staff are required to participate in this training, and if other CVUSD high schools plan to participate in this program. Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.
- Q. Student Services Approval of Amendments to Board Policy 5141.5 Mental Health Trustee Goldberg made the motion to approve, seconded by Trustee Gorback. The Board discussed edits to the verbiage that was revised at the previous Board meeting and reached consensus to approve the requested revisions. Dr. McLaughlin directed Dr. Egans to work with Trustee Powell to clarify the recommended revisions.

Trustee Goldberg amended her motion to approve Board Policy 5141.5 – Mental Health as amended, seconded by Trustee Powell. **Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.**

Trustee Gorback made the motion to approve the remainder of the Consent Agenda as amended, seconded by Trustee Powell. There was no Board discussion on this agenda item. **Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.**

5. INFORMATION/DISCUSSION ITEMS – GENERAL

A. Instructional Services and Student Services - Presentation: Summer Learning Programs

Mr. Loo and Dr. Egans provided information on this year's Summer Learning Programs,
including an overview of each program offered at the elementary, middle school and high
school levels, including Summer Learning camps, Expanded Learning Programs (ELOP), credit
recovery and acceleration opportunities, Extended School Year (ESY), English Learner programs,
and Early Back Intervention, along with information on student populations served, and student
participation and pass rates. Dr. Hayek responded to Dr. McLaughlin's question regarding why

the district partners with Learning 4 Life, and Mr. Loo responded to questions from Board members regarding the increase in students served from the prior year, the percentage of students identified in need who participated, and assessment data on each program and respective student progress and participation rates.

B. LCAP/Budget Committee Discussion

The Board and Executive Cabinet discussed the state's upcoming adjustments to the LCAP template and a timeline for district adjustments, revisions for next year's focus, metrics, and strategies, information needed to provide the LCAP/Budget committee with a charge or specific direction, continued stakeholder engagement, and whether to pause the committee's work until mid-year or continue throughout this school year. The Board reached consensus to continue the discussion regarding providing the LCAP/Budget Committee with a charge or specific direction when information is provided by the state in November or December.

C. Business Services - Approval of Amendments to Administrative Regulation 3320 - Claims and Actions Against the District

Dr. Hayek provided background on the updates from Gamut related to specific time limits on claims taken against the district and the extension of claims related to childhood sexual assault cases. Dr. Hayek responded to a Board member's question regarding whether the Gamut notes are provided in the finalized version of this Administrative Regulation.

D. Business Services - Approval of Amendments to Administrative Regulation 3515.6 - Criminal Background Checks for Contractors

Dr. Hayek provided background on the updates from Gamut related to the requirement for appropriate background checks for any contractors present around students. Dr. Hayek responded to a Board member's question regarding the process by which we request and/or confirm criminal background checks on contractors.

- E. Business Services Approval of Amendments to Board Policy 3516.5 Emergency Schedules Dr. Hayek provided background on the updates from Gamut related to the requirement for appropriate background checks for any contractors present around students. Dr. Hayek responded to a Board member's question regarding the process by which we request and/or confirm criminal background checks on contractors.
- **F. Business Services Approval of Amendments to Board Policy 7110 Facilities Master Plan**Dr. Hayek provided background on updates from Gamut related to recent changes in law regarding schools building residential housing on district property. There was no Board discussion on this agenda item.
- **G. Business Services Approval of Amendments to Board Policy 7310 Naming of Facility**Dr. Hayek provided background on updates from Gamut related to the improvement of language giving the Board control over naming rights or the establishment of memorials. There was no Board discussion on this agenda item.
