### 5. INFORMATION/DISCUSSION ITEMS - GENERAL

A. Student Services/Instructional Services – Presentation: Diversity, Equity and Inclusion Dr. Rogers presented information on the District's Diversity, Equity and Inclusion plan, including the plan's purpose, how we define diversity, equity and inclusion, legal foundations and respective Board Policies and Administrative Regulations, the plan's eight goals and current and future actions that align with CVUSD's LCAP goals, measures of success, Antibias Education Grant Program principles, actions and implementation, professional development, and next steps.

President Gill announced that there was one (1) public comment request submitted, and that speaker received three (3) minutes to speak.

Dr. Rogers then responded to questions from Board members regarding the plan's creation process and next steps, measurements of success, explanation on the ordering of goals, plan implementation, strategies for monitoring and oversight, measurable outcomes and expectations, feedback from stakeholders and school sites, opportunities for other cultures not specified in Goal 3, antibias grant implementation, and inclusion of ableism in the plan.

### B. Instructional Services – Presentation: Transitional Kindergarten (TK)

Dr. Sellers and Mrs. Stovall presented information on the District's Transitional Kindergarten (TK) program, including the history of TK in CVUSD, current and past TK student enrollment, TK birth date requirements, principles of integrated instruction and play-based learning, milestone comparisons for four and five year old students, inclusion for specialized programs, curriculum adaptations for students with disabilities, English learners, and Dual Language Immersion, a typical TK daily schedule, and information for parents interested in future TK enrollment. Dr. Sellers and Mrs. Stovall responded to questions from Board members regarding the district's flexibility with TK guidelines, training opportunities for TK teachers and classroom aides, parent interest in TK in the SHINE Homeschool program, and school choice/sibling priority for TK students and families.

### C. Board of Education - Discussion on City of Thousand Oaks Crossing Guard Program

The Board discussed issues with the current City of Thousand Oaks Crossing Guard Program and whether they, as a collective Board, would like to provide the city with their shared thoughts on the possible removal of crossing guards based on the numerical data of pedestrian traffic at staffed intersections. The Board reached consensus to develop their shared thoughts on this topic.

# D. Business Services – Approval of Amendments to Independent Citizens' Bond Oversight Committee By-laws

Dr. Hayek clarified the amendments to the Independent Citizens' Bond Oversight Committee By-laws and responded to questions from Board members regarding whether student representatives are required to and confirmed to live within the district boundaries, and if they can serve on the executive committee. Based on the Board's discussion, Dr. Hayek agreed to revise the by-law language in Section 5.2(c) related to student representative residency requirements and provide the revisions to the Independent Citizens' Bond Oversight Committee at their meeting in December. These amendments will be brought back to the Board for approval after the Committee's review.

## E. Human Resources – Approval of Amendments to Board Policy 4117.3 – Personnel Reduction

Mrs. Ashmore provided background on the language amendments specified by Gamut relating to the determination of the order of layoff language and the first offer of substitute employment to employees who have been affected by personnel reduction. There was no Board discussion on this agenda item.

# F. Board of Education – Approval of Amendments to Board Bylaw 9324 – Minutes and Recordings

Dr. McLaughlin clarified that the language amendments were specified by Gamut, relating to the recording or broadcasting of Board meetings and the reflection of official Board actions to be included in the minutes. There was no Board discussion on this agenda item.

# G. Triunfo Site – 975 Evenstar Ave., Westlake Village, CA 91361 (Carden Conejo School – Tenant)

President Gill announced that there were sixteen (16) public comment requests submitted, and each speaker received three (3) minutes to speak. Dr. McLaughlin then provided the Board with the background and timeline of the Carden lease agreement. He clarified that an agreement is, and has been, available for Carden to sign, and that Dr. Hayek would be available for further conversations if Carden is interested in CVUSD's proposed agreement.
