H. Reorganization of the Board of Education

President Gill turned the Board meeting over to Dr. McLaughlin, and Dr. McLaughlin explained the Board reorganization process, stated that the Board had the ability to choose Board representatives for various committees or postpone that decision for a later Board meeting, and opened the floor for nominations for Board President.

Trustee Gill nominated Trustee Goldberg for Board President, and Trustee Goldberg accepted the nomination. Dr. McLaughlin asked if there were any other nominations for Board President or any comments or discussion, which there were none. **Motion carried: 5-0, with an honorary "yes" vote from Trustee Kahl.**

President Goldberg continued the reorganization process by opening up the floor for nominations for Board Vice President. Trustee Sylvester nominated Trustee Powell for Board Vice President, and Trustee Powell accepted the nomination. President Goldberg asked if there were any other nominations or discussion, which there were none. **Motion carried 5-0, with an honorary "yes" vote from Trustee Kahl.**

President Goldberg opened up the floor for nominations for Board Clerk. Trustee Gill nominated Trustee Gorback for Board Clerk, and Trustee Gorback accepted the nomination. President Gill asked if there were any other nominations or discussion, which there were none. **Motion carried 5-0, with an honorary "yes" vote from Trustee Kahl.**

A. Board of Education – Approval of Scheduled Regular Board Meeting Dates for the Remainder of the 2023-2024 School Year and a Portion of the 2024-2025 School Year Trustee Powell made the motion to approve, seconded by Trustee Gorback. There was no Board discussion on this agenda item. Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.

B. Board of Education - CSBA Delegate Assembly Nominations

Trustee Sylvester made the motion to approve, seconded by Trustee Gorback. There was no Board discussion on this agenda item. **Motion carried: 5-0, with a preferential "yes" vote from Truste Kahl.**

C. Student Services – Adoption of Resolution #23/24-17: International Holocaust Remembrance Day

Trustee Gorback made the motion to approve, seconded by Trustee Powell. President Goldberg commented on the importance of this resolution. There was no Board discussion on this agenda item. **Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.**

President Goldberg convened the Public Hearing at 7:41 p.m. After no public comment requests were submitted, President Goldberg closed the Public Hearing at 7:41 p.m. There was no Board discussion this agenda item.

F. Human Resources – Approval of Tentative Agreement Between the Conejo Valley Unified School District and the Conejo Valley Pupil Personnel Association (CVPPA)

Trustee Sylvester made the motion to approve, seconded by Trustee Powell. There was no Board discussion on this agenda item. **Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.**

G. Business Services – Approval of 2023-2024 First Interim Financial Statements

Trustee Sylvester made the motion to approve, seconded by Trustee Gorback. Dr. Hayek presented information on the 2023-2024 First Interim Financial Statements, including Education Code requirements for reporting, budget cycle and reporting schedule, fiscal and budget updates from the state, 2023-2024 First Interim estimated revenues, expenses, and projected ending fund balances, multi-year projections with factors and budget assumptions, other fund balances, and 2023-2024 Stimulus fund balances. Dr. Hayek responded to questions from Board members regarding the reflection of restricted budget expenses in end of year balances, projected expenses, and budget assumption factors.

H. Business Services – 2022-2023 Financial Audit Report and Annual Comprehensive Financial Report

Trustee Powell made the motion to approve, seconded by Trustee Sylvester. Dr. McLaughlin and Dr. Hayek commented on the financial audit process and highlighted specific audit details and findings. There was no Board discussion on this agenda item. **Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.**

I. Business Services – Approval of Resolution #23/24-16: Authorizing the Issuance of CVUSD Election of 2014 General Obligation Bonds, Series E, and Actions Related Thereto
Trustee Gorback made the motion to approve, seconded by Trustee Gill. Dr. Hayek confirmed that there were no changes regarding the bond issuance since the discussion at the previous Board meeting. Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.

5. INFORMATION/DISCUSSION ITEMS - GENERAL

A. Instructional Services – Presentation: California Principals Support (CAPS) Network CVUSD Middle School Principals Shane Frank, Jason Klinger, and Nicole Judd presented information on the California Principals Support Network (CAPS) professional development, including an overview of the training purpose, structure, and topics; description and development of Professional Learning Communities (PLCs); PLC guiding principles and cultural shifts in fundamental purpose and use of assessments; feedback from teacher and staff teams; and next steps. District staff responded to questions from Board members regarding how PLC teams are formed and function at school sites, how PLCs are affected by grade transitions, the impact from these training and collaboration efforts, classroom implications, and the extension of this training to other secondary schools.

B. Board of Education – Approval of Amendments to Board Bylaw 9124 – Attorney

Dr. McLaughlin provided background on the language amendments specified by Gamut related to the Board's ability to request proposals for attorney firms and Board member access to attorney use. Dr. McLaughlin clarified that the language amendments do not change current district practice and that the use of an attorney by the Board would require a vote for Board approval. Dr. McLaughlin responded to a Board member's question regarding whether language in the bylaw is needed to codify the requirement of a Board majority vote for Board attorney use. The Board reached consensus to add language regarding the requirement for a Board majority vote.

C. Instructional Services – Approval of Amendments to Board Policy 0410 – Nondiscrimination in District Programs

Mr. Loo provided background on the language amendments specified by Gamut related to updates to Assembly Bill 1078 requiring districts to include a statement in policy prohibiting discrimination, harassment, intimidation, and bullying as applicable to all acts of the Governing Board and Superintendent in enacting policies and procedures that govern the district, and regarding a district's legal responsibility to provide accurate instructional materials. There was no Board discussion on this agenda item.

D. Instructional Services – Approval of Amendments to Board Policy and Administrative Regulation 1312.2 – Complaints Concerning Instructional Materials

Mr. Loo provided background on the language amendments specified by Gamut related to updates to Assembly Bill 1078 requiring the California Department of Education (CDE) to develop guidance and public educational materials to ensure public access to information about educational laws and policies, and other updates to the procedures for complaints concerning instructional materials. There was no Board discussion on this agenda item.

E. Business Services – Approval of Amendments to Board Policy and Administrative Regulation 3230 – Federal Grant Funds

Dr. Hayek provided background on the language amendments specified by Gamut related to new laws regarding the use and accounting of federal grant funds, the extension of the timeframe for submitting the final performance report, and other minor changes. There was no Board discussion on this agenda item.

F. Business Services – Approval of Amendments to Board Policy 3460 – Financial Reports and Accountability

Dr. Hayek provided background on the language amendments specified by Gamut related to the addition of materials for districts facing insolvency who are considering applying for an emergency apportionment. There was no Board discussion on this agenda item.

G. Human Resources – Approval of Amendments to Board Policy and Administrative Regulation 4113 – Assignment

Mrs. Ashmore provided background on the language amendments specified by Gamut related to the assignment of teachers based on the grade level and subject matter of their respective credential, assignment to departmentalized classes outside their credential authorization, assignment to elective courses outside their credential authorization, and assignment to special schedules. Mrs. Ashmore and Dr. McLaughlin responded to a Board member's questions regarding teacher misassignments and the monitoring and reporting process.

A. Future Board Topics / Activities

Board members did not add any topics for discussion at future Board meetings

B. Adjournment
