5. INFORMATION/DISCUSSION ITEMS – GENERAL

A. Presentation: Local Control Accountability Plan (LCAP) and Budget Overview for Parents (BOP) Mid-Year Update

Mr. Loo provided a mid-year update on the LCAP and BOP, which included the background and purpose of the mid-year update, mid-year report metrics, expenditures, and actions; highlighted metrics for all four LCAP goals, including 2020-2021 baseline information, desired outcomes for 2023-24, the 2023-24 mid-year update, and current status; and highlighted actions for all four LCAP goals, including the adopted budget, year-to-date expenditures, and implementation status. Mr. Loo responded to questions from Board members regarding valuable information gained from this mid-year update, next steps, if any, for the distribution of this information, identification of LCAP goal types, how completion of individual metrics are identified, and 2022-23 data points reflected in the 2023-24 California Dashboard results.

B. Presentation: Data at Every Level: Presentation on Student Progress

Mr. Loo, along with Principals Aileen Wall, Shane Frank, and Eric Bergmann, presented multi-level data on student progress at the school and district level, which included definitions for student groups and data level types — satellite data, map data, and street data; California Dashboard results for English Language Arts and Mathematics, CAASPP participation rates, English Learner progress, the California Alternative Assessment for eligible students with IEPs, Least Restrictive Environment data, proficiency and grade distribution data, high school graduation rates, pass rates for Advanced Placement (AP) and International Baccalaureate (IB) testing, feedback from students and staff, site level processes for elementary, middle, and high school; and a summary of district level data, including data reviewed and corresponding actions. Mr. Loo and the principals responded to questions from Board members regarding incentives to increase data collection and reflection on key findings.

C. Board of Education - Adoption of New Board Policy 0100 - Philosophy

Dr. McLaughlin stated that Board Policy 0100 – Philosophy had not been adopted by our district previously and is solely based on Gamut language. Board members discussed whether to approve the Series 0000 Board Policies related to the district's vision, goals, and philosophy with the stated Gamut language, or to form a Board ad hoc committee to review these policies to include CVUSD drafted language tied to the district's LCAP goals. The Board reached consensus to create a Board ad hoc committee, consisting of Trustees Powell and Sylvester, to review the Series 0000 Board Policies and Administrative Regulations and bring these policies

and regulations back to the Board with suggested amendments.

D. Board of Education – Approval of Amendments to Board Bylaw 9321 and Exhibits 9321 (1) and (2) – Closed Session

Dr. McLaughlin provided background on the amendments specified by Gamut related to an appellate court ruling clarifying the process by which an item is agendized in closed session when based on a threat of litigation made by a person outside of an open meeting, and clarifications in the exhibits related to specific agenda descriptions for closed session items and descriptions to report out for specified closed session items. There was no Board discussion on this agenda item.

E. Instructional Services – Approval of Amendments to Board Policy 5145.3 – Nondiscrimination/Harassment

Mr. Loo provided background on the amendments specified by Gamut related to Assembly Bill 1078, which requires that district policy prohibiting discrimination, harassment, intimidation, and bullying includes statements that the policy applies to all acts of the Governing Board and Superintendent, and clarifies when it is unlawful discrimination for the Board to refuse to approve the use or prohibit the use of any textbooks and instructional materials. There was no Board discussion on this agenda item.

F. Student Services – Approval of Amendments to Board Policy and Administrative regulation 6173.1 – Education for Foster Youth

Dr. Egans provided background on the amendments specified by Gamut related to Senate Bill 532, which requires districts to report the number of foster youths who graduated with an exemption from district-established graduation requirements. The amendments on the administrative regulation are related to amendments to the definition of foster youth, requirements for districts to provide home-to-school transportation with a fee exemption, clarification on the educational rights holder, and additional requirements and exemptions from graduation requirements for foster youth based on when they transfer into a school district. There was no Board discussion on this agenda item.

G. Human Resources – Approval of Amendments to Board Policy 4112.9 and Approval of New Exhibit 4112.9-E(1) – Employee Notifications

Mrs. Ashmore clarified that the amendments specified by Gamut included the addition of policy references based on updated law, and a new exhibit detailing when employee notifications are required to be made and which employee groups are required to receive the notifications. There was no Board discussion on this agenda item.

6. ADJOURNMENT

A. Future Board Topics / Activities

Board members reached consensus to provide direction to the Superintendent to create an ad hoc committee to review the district's current dress code, solicit stakeholder feedback, and report feedback and suggested amendments back to the Board at a future meeting.

B. Adjournment

President Goldberg adjourned the Open Session at 9:56 p.m. The next regularly scheduled Board meeting will be Wednesday, March 6, 2024, 5:00 p.m. Closed Session; 6:00 p.m. Open Session, at Conejo Valley High School in the CVUSD Board Room, 1402 E. Janss Road, Thousand Oaks.
