# A. Business Services - Receipt of the Final Report of Sale for Election of 2014 General Obligation Bonds, Series E

Trustee Sylvester made the motion to approve, seconded by Trustee Gorback. Dr. Hayek introduced Mr. Kim from Piper Sandler, who discussed the essential components of the district's successful bond sale, including a favorable interest rate environment, maintenance of a "Aa3" credit rating, a summary of investor orders for Measure I Bond Series E, an overview of the bonds and the bond repayment schedule, sources and uses of funds received, and a breakdown of issuance costs. Board members commented on the importance of providing communication to the public on the success of the bond oversight process. **Motion carried:**5-0, with a preferential "yes" vote from Trustee Kahl.

### 5. INFORMATION/DISCUSSION ITEMS – GENERAL

A. Instructional Services - Presentation: Madroña Academy of the Arts and Sciences Madroña Principal Gina Mandell presented information on Madroña's program and the future transition to Madroña Academy of the Arts and Sciences, including the mission/vision

statement and core values, class breakdown by grade level, student support, campus climate, dance and science grants through community partnerships, specialized instruction for the arts, science, and experiential learning, uniform rollout, and next steps to become an official magnet school. Ms. Mandell responded to questions from Board members regarding how the district can support the magnet school transition, transition effect on attendance boundaries, and tapping into community and alumni support.

B. Instructional Services - Presentation: DATA Academy at Newbury Park High School
Newbury Park High School Principal Steve Lepire introduced DATA Academy teachers Robert
Martin and Leilani Alamillo, who presented information on the DATA Academy's focus,
definition of a California Partnership Academy, grade level course requirements and careerfocused sequence of electives, curricular integration, field trip opportunities and guest
speakers, technology in core classes, 3D printing, extra-curricular activities, mentorships, and
student support and tutoring options. District staff responded to questions from Board
members regarding whether students can join the academy after their tenth-grade year (first
year program is offered) and how that effects course selection and completion, graduation cord
color for DATA Academy students, ability to accommodate all interested students, and student
transition after graduation.

# C. Instructional Services - Approval of New High School Core Literature Title - They Called Us Enemy

Mr. Loo provided background on the core literature approval process and parent preview opportunities and stated that this agenda item would come back for information again at the next Board meeting and for approval at the subsequent Board meeting. There was no Board discussion on this agenda item.

# D. Instructional Services - Approval of Amendments to Board Policy 6177 - Summer School Learning Programs

Mr. Loo stated that the proposed reflect Gamut updates clarifying that summer learning programs are part of the Expanded Learning Opportunities Program (ELO-P), to reflect the requirement to offer access to students specified in AB 181 and 185, and to reference new guidance from the California Department of Education clarifying that districts are prohibited from charging fees for summer school. Mr. Loo responded to questions from Board members regarding how often students that are not listed as priority students enter the lottery and are able to access the program, program demand, and discussed verbiage revisions related to the rationale for summer school learning programs. The Board reached consensus on the discussed revisions, which will be amended prior to Board approval.
