<ul style="list-style-type: none"> • Minimum 2-hour rental for all facilities. • The number of custodians shall be determined by the District depending on the use and number of participants. • Custodial fee will be charged for set-up and clean up of rooms when requesting chairs and tables or any other type of special set-up (limitations - call for information). • All interior weekend use requires custodian/representative to be on campus for the duration of the rental, hourly fee is in addition to the hourly facility charge. • Outdoor weekend use that does not require access to restrooms shall be assessed a \$50 open and close fee for access to fields/courts, etc and no custodian/representative will remain on campus, therefore user groups assume all responsibility for clean up. ADDITIONAL			
All users must comply with District Policy, Administrative Regulation, and Rules and Regulations. The District has the right to cancel any use for any bonafide reason and suspend outdoor facility and field use, including uses subject to an issued permit, for games, practices and other uses whenever field conditions might result in damage to the fields or injury to players.			
Reservations must be submitted at least two weeks prior to intended use date(s). Full payment must be received by the District prior to use. Cancellation Policy: Renter must notify the Civic Center Coordinator through Facilitron of a cancellation 7 business days in advance to avoid paying \$25 cancellation charge. Five or more cancellations without notice may result in denial of future use.			
Still or Video Shoot - call 805-498-4557 x7501 for information - If you are interested in using any District facility for commercial film and television production, we quote location fees on a case by case basis. We require a copy of the script and proof of insurance. Our fee is based on the number of vehicles, size of the crew, time of year, and the length of the shoot. Many of our schools and locations are within the 30-mile studio zone.
