DAC Report:

- Asst SI Kenny Liu opened the mtg with a planned discussion about PSPS (Public Safety Power Shutoffs), in response to the recent wind/fire/power events in Southern CA.
- He introduced Dr Hayek with CVUSD to explain district policies, practices etc. Dr Hayek discussed the State grants CVUSD we received, worth about \$13-14m. Out of 28 schools total in District, 14 sites in CVUSD received the batteries. The schools that received batteries were chosen based on matching the criteria for the need of the battery packs, such as size of school, their power output, location of panels, etc.
- They were not meant to be long term solutions (meaning many days/weeks) of power being out but they do supply the sites with full power. 18-24 hrs of battery life and they need to recharge (just like a hybrid car)
- 2 schools already have diesel generators but they are disconnected now because they got battery packs. District is thinking of repurposing them but they also might be too old to be worth going forward.
- There is one portable generator (smaller)that basically went on tour during the PSPS(we received?) and they are looking to purchase 2 more of those (looking to get the same brand/model so their permit can be the same and the Quick Connects at the sites can be the same) \$80-90K per generator
- Trying to make the Quick Connects at every school which allow for instantaneous hook up of generator that can be dropped off, at least at the 3-4 school sites that consistently lose power (not us). And prioritizing schools that have bad cell sec (WLE)
- These generators allow for power for Critical Components (smoke alarms, basic analog phone line) and some outlets
- In terms of safety re communication the schools are always able to communicate with each other/District because of the 2 repeaters in District allowing for all sites to communicate with each other and also the main hub on Mitchell Rd (Newbury Park).
- Always on the lookout for new grants like nat gas generators or solar etc (solar was questioned and basically they have looked at it but it's just too costly and the pay back is 28-30 years. Also most sites just dont draw enough power to



necessitate it (most sites have switched to all LED bulbs, etc so much more energy efficient)

- They gave a huge shoutout and kudos to school site councils (staff/teachers) for being keeping the sites safe and open.
- SO, there is now a PSPS Task Force in place to continue reviewing practices, and the main idea now is to focus on How to Prepare, and How to handle as leaders on your campus (positivity), and also Messaging
- Lastly they dispelled the myths around staying open. CVUSD did not stay open to get money from the state. They could have easily filed a J13 form which is a form filed for emergency situations but it also applies to majority low attendance due to emergency situations so if their goal was to stay open to get money from the state (ADA?) they could have just closed and filed this form.
- The idea here is that schools, in the absence of freeways being shutdown, obviously Evacuation Warnings, dangerous air quality, etc is a safe place (sometimes even safer than others) for students to be. There are some families who are first responders or cannot miss work to stay home with their children and so schools needed to remain open. SI Mark McLoughlin will now (and especially after leading us through COVID) will always lean towards having schools open again in the absence of freeways being shutdown, obviously Evacuation Warnings, dangerous air quality
- Practices and plans with regards to the PSPS will be incorporated into the CSSP (Comprehensive School Safety Plans) going forward
- We broke out on to groups to give feedback mainly on what Parents Could Expect and various feedback was given (see form - subs, emergency card printed and on thumb drive, messaging the why, what and how etc)
