Project Planning

- Establish Project Budget
- Determine Scope
- Define Realistic Timeline

All of the above goes hand-in-hand.
Adjust each if needed.



Determine Project Delivery Method

- Design-Bid-Build (DBB)
- Design-Build (DB)
- Multi-Prime
- Trade Contracting
- Lease-Lease-Back (LLB)



Determine Construction Contracting Method

- Below \$15,000 single Purchase Order negotiated, however, we try to obtain at least 3 bids if possible
- Between \$15,000 and \$175,000 CUPCCAA
 (California Uniform Public Construction Cost Accounting Act)
- Above \$175,000 Formal Bid per PCC (Public Contract Code)

Typical Project Phases

- Pre-Design/Feasibility Study
- Design: Schematic Design,
 Design Development,
 Construction Documents,
 DSA Approval
- Bid and Award
- Construction
- Closeout and Occupancy



Division Of State Architect (DSA)

- State Agency Overseeing Public K-14 School Construction
- Approves Plans, Oversees Construction
- Areas Of Concern:
 - Structural Safety
 - > Fire And Life Safety
 - American With Disabilities Act (ADA)



Construction Phase

- Notice to Proceed (NTP)
- Pre-Construction Meeting
- Submittals and Request For Information (RFI)
- Construction Cost Monitoring: Payment Requests and Change Orders
- Construction Time Monitoring: Short-Interval Schedules
 And Critical Path Method (CPM) Schedules
- Claim Avoidance and Resolution
- Key to Success: Proactive Issue Resolution And Proper Documentation
