H. Discussion on CDPH January 14, 2021 Reopening Guidance

Dr. McLaughlin presented information on the updated reopening guidance received from the California Department of Public Health (CDPH), including the criteria and processes for school reopening under the Blueprint for a Safer Economy framework, response to COVID infections for student or staff confirmed cases, implementation of "stable groups" of students and staff, CVUSD's timeline of events, Blueprint Metrics by zip code, and CDPH's response to CVUSD. There was Board discussion on this agenda item, to which Dr. McLaughlin answered Board members' questions and provided clarifications.

I. Business Services - Child Care Program Discussion

Dr. Hayek presented information on the Child Care Program financials, including fund balance, revenues and expenses, considerations on estimated General Fund Reserve support, staffing changes and modifications to the program, the 2020-21 program timeline and next steps. There was Board discussion on this agenda item, to which Dr. McLaughlin and Dr. Hayek answered Board members' questions and provided clarifications.
