A. Call the Meeting to Order

Call to Order: President Sylvester called the meeting to order at 6:00 p.m.

President Sylvester announced that the following items were discussed in Closed Session:

D. Approval of the Agenda

Trustee Goldberg made the motion to approve the agenda as amended, pulling items 4B, S and T for a separate vote, seconded by Trustee Gorbach. **Motion carried: 5-0, with a preferential “yes” vote from Student Trustee Xu.**

E. Report from Parent Organization – District English Learner Advisory Committee (DELAC)

Carina Pivaral, DELAC Chairperson, provided an update from DELAC in Spanish, with English translation by Dr. Araiza, on previous meeting topics discussed, including mask and safety protocols, mental health supports, ELPAC administration, and the purpose of DELAC. Ms. Pivaral stated that DELAC also discussed other topics, including the new Dual Language Immersion program, importance of school attendance, enrollment information, kindergarten requirements, and the Project2Inspire program presentations and available classes.

F. Comments – Public

President Sylvester announced that there were four (4) public comment requests submitted (2 via telephone; 2 via Zoom), and each speaker received three (3) minutes to speak. Dr. McLaughlin provided clarifications on comments from public speakers.

G. Comments – Board of Education

President Sylvester announced that there was one (1) public comment requested submitted (via Zoom), and that speaker was stopped in the process of providing public comments on an agenda item that has already passed and offered the opportunity to comment on the current agenda item, which he declined. Individual Board members then provided their comments.

H. Comments – Superintendent

President Sylvester announced that there was one (1) public comment request submitted (via Zoom), and that speaker received three (3) minutes to speak. President Sylvester and Dr. McLaughlin provided clarification on the public speaker’s comment, and Dr. McLaughlin then provided his comments.

A. Board of Education – CSBA Delegate Assembly Nominations

Trustee Gill made the motion to approve Daniel Sandoval, Shelly Griffen, Efrain Cazares, and Lauren Gill as a write in candidate, seconded by Trustee Goldberg. **Motion carried: 5-0, with a preferential “yes” vote from Student Trustee Xu.**

B. Human Resources – Notice of Public Hearing to Approve the Submission of the Disclosure of Collective Bargaining Agreement (AB 1200) for 2021-2022 and 2022-2023

President Sylvester convened the Public Hearing at 7:12 p.m. There was one (1) public comment request submitted (via Zoom), and that speaker received three (3) minutes to speak. Dr. McLaughlin and Mrs. Valentine provided clarifications on the public speaker's comment. There was no Board discussion on this agenda item. President Sylvester closed the Public Hearing at 7:16 p.m.

C. Human Resources – Approval of Tentative Agreements Between the Conejo Valley Unified School District and Conejo Valley Pupil Personnel Association (CVPPA) and the Unified Association of Conejo Teachers (UACT), and Approval of Salary Increase for Classified Management/Supervisory, Certificated Management, and Classified Non-represented Employees, including Confidential Employees and Campus Safety Assistants

Trustee Gorbach made the motion to approve, seconded by Trustee Capobianco. There was no Board discussion on this agenda item. Student Trustee Xu was unable to vote on this agenda item as it pertained to personnel matters. **Motion carried: 5-0.**

D. Instructional Services – Approval of Resolution #21/22-32: Read Across America Week

Trustee Goldberg made the motion to approve, seconded by Trustee Gill. There was no Board discussion on this agenda item. **Motion carried: 5-0, with a preferential “yes” vote from Student Trustee Xu.**

E. Student Services – Approval of Resolution #21/22-28: In Support of National Women's History Month

Trustee Gorbach made the motion to approve, seconded by Trustee Goldberg. There was no Board discussion on this agenda item. **Motion carried: 5-0, with a preferential “yes” vote from Student Trustee Xu.**

F. Business Services – Approval of Resolution #21/22-38: Authorizing the Submission of the Use of School Property Proceeds to the State Allocation Board and Subsequent Transfer of \$3,500,000 from the Proceeds of the Sale of District Real Property Located at 2498 Conejo Center Drive, Thousand Oaks, CA to ARC Investment Group, LLC.

Trustee Goldberg made the motion to approve, seconded by Trustee Gorbach. Dr. Hayek answered questions from Board members regarding certification requirements related to future construction projects, potential use of funds, and the timeframe for textbook purchases. **Motion carried: 5-0, with a preferential “yes” vote from Student Trustee Xu.**

received three (3) minutes to speak. Dr. McLaughlin provided clarification on the public speaker's comments. The Board reached consensus to delete "insulting or demeaning language" from the first paragraph on page 2 under "Disruptions."

Trustee Goldberg amended her motion to adopt Board Policy 1313 – Civility as amended, seconded by Trustee Gorback. **Motion carried: 5-0, with a preferential "yes" vote from Student Trustee Xu.**

S. Business Services – Acceptance of Donations/Gifts

Trustee Gorback made the motion to approve, seconded by Trustee Capobianco. Trustee Goldberg recused herself from the discussion and vote due to the agenda item involving her former employer. There was no Board discussion on this agenda item. **Motion carried: 4-0, with a recusal from Trustee Goldberg and a preferential "yes" vote from Student Trustee Xu.**

Trustee Capobianco made the motion to approve, seconded by Trustee Gill. Trustee Goldberg recused herself from the discussion and vote due to the agenda item involving her former employer. There was no Board discussion. Student Trustee Xu was unable to vote on this agenda item as it pertained to employee payroll. **Motion carried: 4-0, with a recusal from Trustee Goldberg.**

5. INFORMATION/DISCUSSION ITEMS – GENERAL

A. Human Resources – Approval of Resolution #21/22-36: Reduce or Discontinue Particular Kinds of Services at the Close of the Current School Year

Mrs. Valentine provided background on the purpose of this resolution and the affected services. There was no Board discussion on this agenda item.

B. Instructional Services – Annual Update to the 2021-2022 LCAP and Budget Overview for Parents

Mr. Loo presented information on the Annual Update to the 2021-2022 LCAP and Budget Overview for Parents, including background on the annual update process, impact to the Budget Overview for Parents, supplement to the Annual Update for the 2021-2022 LCAP, mid-year update on metrics, and mid-year expenditure and implementation data on all actions identified in the 2021-2022 LCAP. Mr. Loo and District staff responded to questions from Board members regarding the amount received and purpose of the Expanded Learning Opportunity Program, potential feedback survey of School Site Councils at the high school level, student reach and timeframe to spend special education learning recovery funding, metric for spending of the A-G completion improvement grant, baseline for the goals/metrics on chronic absenteeism, breakdown of current and past student demographics for D and F rates, upcoming text additions and funding sources for the core literature program, baseline for SBAC, summative assessments for English/Language Arts and Math, metrics and demographic breakdown of student participation in co and extra-curriculars, inclusion of district progress on student engagement in the 2022-2023 LCAP, plan to generate stakeholder feedback, metrics on social emotional learning, and the timeframe and plan to reallocate unused funds.

C. Instructional Services – Presentation: Update on Conejo Valley High School (CVHS) Student Bus Transportation

Mr. Loo presented information on the new CVHS transportation route, including a timeline of actions, feedback from students, communication provided to students and families, creation of the route, participation numbers, costs, and student requirements. Dr. Hayek responded to a Board member's question regarding the creation of specific route stops.

D. Student Services – Approval of Amendments to Administrative Regulation 5125 – Student Records

There was no Board discussion on this agenda item.

E. Student Services – Approval of New Board Policy 6159 and Amendments to Administrative Regulation 6159 – Individualized Education Program

Dr. Miller requested that the Board allow her to modify verbiage to clarify that the policy specifically pertains to an initial IEP, to which the Board agreed through consensus. The revisions will be brought back for Board approval at a future Board meeting.
