MINUTES

1. OPENING PROVISIONS

A. Call the Meeting to Order and Roll Call

Call to Order and Roll Call: President Goldberg called the meeting to order at 10:06 a.m. Board Members present: President Cindy Goldberg, Vice President Jenny Fitzgerald, Bill Gorback, Sandee Everett, Dr. Betsy Connolly, and Student Board Trustee Jordan Scott. 2. STUDY SESSION

A. Reopen and Redesign Study Session (Information/Discussion)

District staff presented information on the purpose of the presentation, guiding principles, current status, major events for 2020-2021 school budgets, stakeholder engagement, teaching and learning models, elementary and secondary schedule options, the Special Education Delivery Matrix, health and safety protocols, updates on childcare, child nutrition, transportation and technology, a learning management system update, and next steps. Board members individually provided comments and questions, to which District staff responded. Mrs. Everett called Points of Order on two separate occasions during the discussion, to which President Goldberg stated that both Points of Order were not founded

The Board reached consensus on moving forward with the Option 3 Teaching and Learning Model, and also reached consensus on simulcasting. The Board did not reach consensus on surveying teachers, parents and staff specifically on Option 3.
